**A RESOLUTION AUTHORIZING A FORMAL EXPRESSION OF SUPPORT FOR THE
IRON SPRINGS PLAZA TRANSPORTION INFRASTRUCTURE IMPROVEMENTS
PROJECT AND THE ASSOCIATED REQUEST FOR GRANT FUNDING FROM THE
MULTIMODAL TRANSPORTATION FUND, AND AUTHORIZING THE
PREPARATION AND SUBMISSION OF AN APPLICATION FOR A MULTIMODAL
TRANSPORTATION FUND GRANT, WITH THE TOWNSHIP SERVING AS THE
GRANT APPLICANT**

WHEREAS, the Board of Supervisors, Hamiltonban Township, Adams County, PA (the "Township") wishes to formally express its support for the Iron Springs Plaza development project (the "Project"); and

WHEREAS, David Sites, (the "Developer") is currently evaluating the pursuit of grant funding through the Commonwealth Financing Authority's ("CFA") Multimodal Transportation Fund ("MTF") to support certain transportation improvements associated with the Project; and

WHEREAS, the CFA's MTF program requires an Authority or Municipal sponsor to serve as the MTF grant Applicant; and

WHEREAS, the Township supports the Project and wishes to serve in the role of Applicant, should the Developer choose to prepare and apply for CFA MTF grant funds; and

NOW THEREFORE BE IT RESOLVED, that Hamiltonban Township, as the Applicant, does hereby authorize the preparation and submission of an MTF application of an MTF grant request of up to \$1.0 million from the Commonwealth Financing Authority to be used for the project known as the ISP Transportation Infrastructure Improvements, which consists of certain transportation improvements associated with the Project.

BE IT FURTHER RESOLVED, that should a contract for the grant be awarded, Hamiltonban Township, as Applicant, shall enter into a cooperation and indemnification agreement with the Developer regarding the Developer's provision of matching funding and the administration of the grant.

BE IT FURTHER RESOLVED, that Hamiltonban Township does hereby designate Robert L. Gordon, Board Chairman, and Doug Woerner, Board Vice-Chairman, as the official(s) to execute all documents and agreements between the Township, the Developer and the CFA to facilitate and assist in obtaining the requested grant.

THIS RESOLUTION IS DULY ADOPTED, by the Board of Supervisors of Hamiltonban Township, Adams County, Pennsylvania, at its regularly scheduled meeting, held on the 5th day of May 2015, which was duly convened in accordance with the law.
