
WHEREAS, Hamiltonban Township owns and operates a John Deere Tractor with boom mower attachment and,





**AN INTERGOVERNMENTAL SERVICE AGREEMENT
BETWEEN HAMILTONBAN TOWNSHIP AND LIBERTY TOWNSHIP, TOWNSHIPS
OF THE SECOND CLASS OF ADAMS COUNTY, PENNSYLVANIA**

THIS AGREEMENT made this ____ day of _____, 2021 by and between Hamiltonban Township and Liberty Township;


WHEREAS, the Municipalities have the power and authority to contract for the purposes of borrowing, lending, exchanging and otherwise sharing vehicles, machinery and/or equipment (collectively, "Equipment"), with operators, with other municipalities; and

WHEREAS, an Intergovernmental Service agreement is defined as "an agreement between municipalities where one municipality agrees to provide services to another for a fee", and

WHEREAS, Hamiltonban Township and Liberty Township agree to the following:


1. For the fee of \$119.00 per hour, Hamiltonban Township Board of Supervisors agrees to provide a John Deere Tractor and boom mower attachment with operator.
2. Hamiltonban Township will coordinate with Liberty Township on the dates and times for the service to be provided.
3. Liberty Township shall provide specific information pertaining to the areas where mowing is to take place.
