## RESOLUTION FOR MINOR ACT 537 UPDATE REVISION

RESOLUTION OF THE SUPERVISORS OF HAMILTONBAN TOWNSHIP, ADAMS COUNTY, PENNSYLVANIA.

WHEREAS Section 5 of the Act of January 24, 1966, P.L. 1535, No. 537, known as the "Pennsylvania Sewage Facilities Act", as Amended, and the rules and Regulations of the Pennsylvania Department of Environmental Protection (Department) adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, require the municipality to adopt an Official Sewage Facilities Plan providing for sewage services adequate to prevent contamination of waters of the Commonwealth and/or environmental health hazards from sewage wastes, and to revise said plan whenever it is necessary to meet the sewage disposal needs of a municipality, and

WHEREAS the selected alternative for the subject Minor Act 537 Update Revision provides for the decommissioning of the Orrtanna Wastewater Treatment (WWTP) owned by Hamiltonban Township and located in Highland Township and construction of a pump station at the same location to convey the sewage to the Cashtown-McKnightstown WWTP owned by the Pennsylvania American Water Company (PAWC) and located in Franklin Township, and

WHEREAS decommissioning of the Orrtanna WWTP involves the removal of any sewage sludge, removal of the lagoon liners, removal of the bridge structures, re-grading of the lagoons and the lagoon area being restored with grass cover, and

WHEREAS the Minor Act 537 Update Revision also provides for the transfer of the Orrtanna WWTP and collection and conveyance system to PAWC, and

WHEREAS if the Orrtanna WWTP and collection and conveyance system are transferred to PAWC, PAWC will be responsible for implementation of the selective alternative in accordance with the Minor Act 537 Update Revision, and

WHEREAS, Hamiltonban Township finds that the subject Minor Act 537 Update Revision conforms to the applicable sewage related zoning and other sewage related municipal ordinances and plans, and to a comprehensive program of pollution control and water quality management.

**NOW, THEREFORE, BE IT RESOLVED** that the Supervisors of the Township of Hamiltonban hereby adopt and submit to the Department of Environmental Protection for its approval as a revision to the "Official Sewage Facilities Plan" of the municipality the above referenced Sewage Facilities Update Revision which is attached hereto.
